# I. CALL TO ORDER

President Stone called the meeting to order at 8:02 a.m.

### II. APPROVE THE MINUTES

Mrs. Hart moved, seconded by Mrs. Poehling, to accept the minutes of the September 11, 2023 Committee of the Whole meetings. The minutes were approved as submitted by **Roll Call Vote**.

# III. FACILITY DEVELOPMENT COMMITTEE (FDC)

# A. Summer 2023 Construction Projects

Mike Bickler of Nicholas and Associates provided an update on chillers noting twohave been received and set at Central and Romona schools. The chiller for Harper was expected to arrive this week and Highcrest's chiller expected to arrive at the end of the month. Chillers will be ready for start-up during spring break.

#### B. Summer 2024 Construction Projects

Joe Papanicholas of Nicholas and Associates provided the budget assessment noting it is at 60% and construction costs are estimated at \$4.5M as anticipated. Majority of work is roofing and mechanical at Wilmette Junior High school (WJHS). Construction documents will be updated and budget assessment at 85% in the coming weeks. The bids will be presented November 9 with the bid opening to be held November 30. Six alternates will be included for flexibility. Mr. Bultemeier reviewed the construction plans for the schools and the alternates to be presented. Updates will be provided at the November committee meeting.

#### C. State Maintenance Grant Application

Last year at this time, D39 applied for and received a \$50,000 state maintenance grant from Illinois State Board of Education (ISBE). ISBE has announced a new year of grants are open for applications. D39 will be applying for the \$50,000 grant application to be attached to the summer 2024 work at WJHS. The Board will be asked to approve the application at the October 23 Board Meeting.

#### IV. SCHOOL FINANCE COMMITTEE (SFC) ITEMS

A. 2023 Tax Levy Estimate

Annually as the District works towards approval of the tax levy, a detailed review of an estimated tax levy is required per law. Mr. Bultemeier provided a presentation on the estimated 2023 tax levy along with the details impacting the levy. The 2023 Levy Estimate will be presented at the October 23 Board meeting and be presented for approval at the November 13 Board meeting.
